A local law Prohibiting overnight parking of motor vehicles on town roads during

SECTION 1. TITLE

This local law shall be known as the "Town of Florence Prohibition of Overnight Parking Law - November 1 until April 1."

SECTION 2. PROHIBITION OF PARKING

No person shall park a motor vehicle, as defined in the Vehicle and Traffic Law, on either side of any town road between 2:00 a.m. and 8:00 a.m. from November 1 until April 1 of the following year.

SECTION 3. PENALTIES

A violation of this Local Law shall constitute a traffic infraction punishable by a fine not to exceed \$50.00 or imprisonment. In addition to the fine, and/ or imprisonment violators shall be responsible for towing and storage of the illegally parked vehicle.

SECTION 4. EFFECTIVE DATE

This Local Law shall be effective upon filing with the Secretary of State.
